

## **Golf Car Rules, Violations, Fines and Policies**

The Golf Car is a huge part of the culture at Ocean Lakes Family Campground. We want everyone to enjoy their time and experience in Ocean Lakes, but the policies and rules are in place to help promote the safety of our guests and our teammates. Our ultimate objective is to make Ocean Lakes Family Campground the most safe and enjoyable family-oriented vacation destination that it can possibly be.

**PLEASE NOTE:** the Golf Car Violations listed below apply to ANYONE operating a Golf Car inside Ocean Lakes, including our Annual Lease Site Holders and their guests. All violations will result in a \$100 fine.

## Ocean Lakes Golf Car Violations include:

- **Underage driving**. Driver must be at least 16 years of age with valid driver's license in their possession (also SC State Law).
- **Reckless driving.** Golf Cars must be operated properly at all times and driven on roadways. No reckless driving, racing or misuse of the Golf Car will be tolerated. Drivers must obey all traffic signs.
- Loud, lewd and vulgar music (or language). Please keep the volume level on radios, stereos, or other audio devices low so others are not disturbed, and only play musicthat is family -friendly.
- Open containers of alcoholic beverages on your golf car (or in your possesson off your site). Please, for everyone's safety, do not drink and drive!
- "Cruising" after hours (during Quiet Hours 11 PM 7 AM) with no legitimate destination.

First Offense: \$100 fine will be levied against the ALS and documentation recorded in the Site's file.

<u>Second Offense:</u> \$100 fine will be levied against the ALS and documentation recorded in the Site's file. The second offense will result in the loss of privilege to have a golf car on the campground for one year. The Golf Car must be removed from the campground or stored in the Golf Car storage area for the one year time period.

Additional Offenses: If violations occur after the second offense, your lease could be in jeopardy.

## Rolling 5-year Probation Plan for Annual Lease Site Golf Car Violations

The golf car violation policy uses a rolling 5-year Probation Plan for golf cars owned by an Annual Lease Site Holder. If you should incur a golf car violation, it goes towards your site and you will be on probation for FIVE YEARS. If no other violations occur during the 5-year probation period then the initial violation will role off.

If you receive a second violation during the five years, then you will lose your golf car privileges for one year and the golf car(s) will have to be removed from that Annual Lease Site. After the one year period is up, the golf car(s) could be returned to the site, however, another violation within five years at that site will require the golf car(s) to be removed again for another one year period.

**VIOLATION NOTE:** If you should incur any violations and lose your Golf Car privileges for one year at your site you may have an Ocean Lakes Golf Car rental at this site. **If any violations occur with an Ocean Lakes' rental golf car, or a renter's privately owned golf car, it will not be a violation against your Annual Lease Site.**
